

These are the release notes for the Wholesale Electricity Market Prudential and Settlement Service (WEM PaSS) 3.7 (Build 3.7-842-2).

This release focused on implementing the WEM Rule changes to FCESS Uplift Payments.

## 2 FCESS Uplift Payments

## 2.1 Rule change

The <u>WEM Amendment (FCESS Cost Review) Rules 2024</u> has introduced changes to FCESS Uplift Payments (see sections 9.9 and 9.10).

These changes are gazetted and effective from Trading Day 20 November 2024 (rule commencement date).

#### Summary of changes related to settlements:

- Remove the payment of FCESS Uplift Payments for the provision of RoCoF Control Service.
- Provide an alternative method of compensation (through Energy Uplift Payments) for Facilities constrained on by AEMO to provide RoCoF Control Service only.
- Provide for Energy Uplift Payments for Facilities that are constrained on by AEMO during a period covered by a Low Reserve Condition Declaration.
- Clarify that Energy Uplift Payments are based on In-Service Capacity Price-Quantity Pairs in Real-Time Market Offers only.
- Modify the FCESS Uplift Payment calculations to avoid over-compensating FCESS providers when their enablement losses are partially or completely covered by other Real-Time Market payments.

## 2.2 Formulation change

The WEM Metering, Settlement and Prudential Calculation Formulation Version 8.0 has been certified and will be published on the <u>AEMO Website</u>. This version is effective for Trading Days from the rule commencement date.

The upstream system WEMDE will provide PaSS with new inputs for the calculations, including Price-Quantity Pairs from the Real-Time Market Offers. Inputs to PaSS are denoted with an "I" reference in the formulation document tables rather than a numerical reference to another formula.

Market Participants can access the new variables via the Settlement Statement detail API, or the Settlement Statement detail CSV files in the WEMS MPI user interface.

## 2.3 Public Data Site change

The shares of each FCESS Uplift Payment allocated to each Frequency Co-optimised Essential System Service are published on the <u>Public Data Site</u> under Post-Reform > Settlements > FCESS Uplift Payments in accordance with clause 9.10.3P of the WEM Rules.

For calendar year 2024, the CSV file will continue to include a column for "FCESS Uplift Share RCS (\$)" but it will only be populated up until the rule commencement date. From calendar year 2025 onwards, this column will be no longer be included in the CSV files.

The "Field Definitions" will include the following clarification in yellow:

#### A FCESS Uplift Share RCS (\$)

The share of the FCESS Uplift Payment for the Registered Facility in the Dispatch Interval, to be allocated to RoCoF Control Service, determined in accordance with WEM Rule 9.10.3M. This value is only applicable for Trading Days prior to 20 November 2024.
